In 2022, each Career and Technical Student Organization (CTSO) will individually hold its state conference or convention in a virtual format; hybrid opportunities may be possible pending Hawaii State Department of Education guidelines. These events are open to all students and advisors participating in DECA; Family, Careers, and Community Leaders of America (FCCLA); FFA; HOSA-Future Health Professionals; and SkillsUSA:

- DECA Virtual Career Development Conference: February 14-25, 2022
- FCCLA Virtual State Leadership Conference and Competitions: February 21-March 4, 2022
- FFA Virtual State Convention: April 18-20, 2022
- HOSA Virtual State Leadership Conference: February 28-March 4, 2022
- SkillsUSA Virtual State Leadership Conference: February 1-15, 2022

Specific conference and convention information will be shared with CTSO chapter advisors. Schools will be responsible for all registration fees, substitute teacher costs, and travel costs (if applicable). Weighted Student Formula funds (Program ID 42100) or state Career and Technical Education (CTE) funds (Program ID 15849) may be used to support participation as indicated in each school's CTE One-Year Plan. Newly established CTSO chapters or those chapters that took a one-year hiatus may use Perkins funds (Program ID 15763) to support student conference registration fees as indicated in each school's CTE One-Year Plan.
